



NAME OF EVENT: 2023-2024 U.S. Supreme Court Term in Review

BRIEF DESCRIPTION: Three expert panelists—a California Supreme Court Justice, a legal expert in the California Governor’s Office, and a skilled Supreme Court advocate—will share their unique perspectives on the 2023-24 U.S. Supreme Court Term and its implications. The panelists will analyze several recent decisions in context. Specifically, the panelists will discuss cases addressing the power of administrative agencies; statutory interpretation decisions, including those concerning Title VII and the Federal Arbitration Act; the interaction between the First Amendment and social media platforms; cases affecting the scope of state authority, including with respect to homelessness; and decisions reflecting the Supreme Court’s evolving approach to the use of history in answering questions of federal law.
